- A key part of the role will be delivering management workshops to our clients up to and including level 5. The location for this would be central London.
- You will be integral to the development of the workshop delivery activity and ensure that it is fit for purpo se and meets the expectation from a grade 1 provider.

Principle Accountabilities:

- Engagement with employers and learners to deliver a quality service meeting KPIs set for starts, new sign ups, leavers and learner progression through to complet ion of qualifications and Apprenticeship Standards.
