### **Job Description**

Job Title: Employment Adviser

**Reports to: Area Manager**

#### Purpose

The role of an Employment Adviser requires a tenacious, highly organised, motivating, and innovative individual, able to work in a fast-paced target driven environment to support people with multiple barriers to move into sustainable employment.

Supporting a caseload o participants, to produce a vocational profile and an effective action plan, offering advice and direction t enable participants t access the support they need. Delivering within an "Employment First" model you will be engaging with employers to support job matching, job carving, and reasonable adjustments. The Employment Advisor works with both the employer and participants during in-work support until a job outcome has been reached.

#### Main Duties and Responsibilities

- 1. Ensure achievement against service delivery KPIs, targets and outcomes. Including Job Entry, sustainability, customer service standards and activity led profiles.
- 2. Progressively manage a caseload of referred customers conducting initial assessments to identify support needs, goals, and motivation.
- 3. Co-production of Vocational Profile and Action Plan to support job matching and empower participant. Understanding the participant needs including health, benefits/budgeting, and the creation of a Positive Health Statement to support employer disclosure.
- 4. Responsible for real time updating of the client database system to ensure quality interventions are recorded and that reporting, and management information data is effectively utilised to ensure a quality journey of support

- 5. Brokering and sustaining excellent working relationships with key local stakeholders to support participant development at all stages of their journey in to sustained employment from Job Centre Plus (JCP), to employers and other community-based organisations, creating positive outcomes for our participants, whilst ensuring non duplication of support.
- 6. Undertake in-work support activities to ensure an individual can maintain their employment, identifying and overcoming any risk to achieving this to ensure sustained employment is achieved.
- Independent, effective caseload management through organising and coordinating a varied timetable of 1-2-1 and group activities; CV Workshops, Application support, job clubs, and other innovative interventions to progress participant caseload to work ready and in to sustained employment bespoke to their needs.
- 8. Maximising access to MyCareerHub, CV and interview assessments, selfserve employability tools, the E-learning resource library and live job search activities.
- 9. Supervise and guide the volunteers to provide participants with additional support to access community provision, thereby creating a 'circle of support'.
- 10. Employer relationship management to create accessible employment pathways. Including engagement with Disability Confident and supporting employers to facilitate reasonable adjustments.
- 11. Providing in work support (IWS) through a co-produced action plan. Identifying circles of support, assisting with Access to Work application, offer of Employer Support (educational information, job accommodations) etc.
- 12. Be fully responsible for all tasks related to journey / case management function including maintaining effective and efficient administrative procedures, prioritising and producing appropriate records and reports.
- 13. Ensure safe working practices are maintained as set out within Shaw Trust's policies/procedures as well as operating within service guidelines when participants require crisis support.
- 14. Maintain an up-to-date working knowledge of the local labour market, training opportunities and relevant support agencies particularly health anc wellbeing service providers.
- 15. Maintain up to date knowledge of the benefit system and entitlements. Utilising Off-Benefit calculations to support informed decisions.
- 16. Provide a quality service which meets contractual requirements.

17. To encourage client feedback and user involvement as directed.

#### Other

- 1. To undertake any further training as identified in the Shaw Trust review procedures.
- 2. Ensure that safe working practices are followed in respect of COSHH and other Risk Assessment control measures.
- 3. - 9. To report to line manager, or other appropriate person, in the event of awareness of bad practice.
- 10. Recycle and manage energy within your environmentin line with Shaw Trust's Strategic aim to adopt green approaches and become carbon neutral.
