

Job Title: Classroom Tutor

Role Overview:

Delivering an integrated programme of training, support and development to learners who require additional support with their Classroom and functional skills learning.

Be responsible for IXION's Additional Learning Support Policy and Processes and ensure awareness of the policy and procedures across all delivery.

• Use a range of techniques and resources tailored to the individual's needs to support the learner throughout their learner journey towar ds achievement.

Manage a caseload effectively, including detailed completion of paperwork to comply with all SFA funding rules and Ofsted Regulations.

- Take an active part in Ofsted inspections including participation in all meetings, training and standardisations as deemed necessar by the company as well as completing and loggin own CPD carried out in line with maintaining occupational competence in your area of expertise.
- Design, develop and deliver an integrated programme to ensure that levels of teaching and learning are high at all times. This needs to include use of a range of delivery methods to take into account individual learning styles of all learners.
- Contribute where necessary to the IXION Self Assessment process.
- Ensure that learner information is accurately recorded and that paperwork, including attendance registers, is submitted to the Administration team by the deadlines set to meet contractual requirements. Report any quality issues immediately.



- Take an active role in Team and Standardisation meetings as arranged by the company as well as actively developing yourself and your colleagues in line with company CPD rules.
- Be available to attend External Verifier visits which relate to the awards you deliver if necessary.
- Highlight and discuss learner issues providing focused learner support where required .
- Support the end-to-end servic approach of the direct delivery team and, where required, assist other team members to ensure that all learners receive their certificates and portfolios in a timely manner.
- Contribute to the overall team achievement of profiled learner outcomes .
- Ensure that all activity complies with Ixion Holdings quality standards and any statutory and Awarding Body standards and requirements .
- Encourage occupational development of your learners via ongoing learning and development and promotion of IXION's services.
- Deliver qualifications across a range of awards where occupationally competent in accordance with the centre's Quality Assurance process.
- Ensure that all students receive the appropriate level of support they need and identify any additional learning needs where applicable.
- Work with the Head of Skills Quality and Internal Quality Assurer's (IQA) to maintain and improve IXION's quality framework across direct delivery programmes including observations of learning performance management and supporting the Self-Assessment process.
